Interested Supplier/Manufacturer/Dealer can send their quotation. Vide letter no. GMCC/Medical Store Dept./Medicines/6640/2023 Dt. 02.08.2024. Due to poor response to above mentioned quotation notice the first extension is given.

Quotation should be sent in sealed envelope (duly sealed by sealing wax) by post or hand delivery so as to reach this office on or before **05/09/2024** upto 5.30 pm.

1. The word "Quotation for the Medicinal Items" and last date of quotation should be clearly written on cover.
2. Quotation received late, will not be accepted under any circumstances.
3. Goods should be at free delivery to Govt. Medical College & Hospital, Chandrapur premises only. (FOR destination - Medical Store Dept. Govt. Medical College & Hospital, Chandrapur) with PAN, and CST/GST Number. Certificates/Documents must be attached as to follows-  
(1) Gumasta - Shop Registration by Municipal Corporation of the city. (2) FDA Certificate - for the Pharmacy shop. (3) Pharmacy Council Certificate of the Entrepreneur (shop owner). (4) PAN card. (5) GST Certificate (6) Income Tax for Assessment Year 2020-21. (7) Bank Details/Cancelled Cheque. (8) One photo of the Entrepreneur
4. Quoted medicines should be strictly according to the specification mentioned in the list and it should be submitted along with the quotation by the Supplier. The rate of the medicine quoted should include all taxes. (GST/CST etc.)
5. After placing the Purchase order to lowest one, the order have to be executed in full within the stipulated time. If the supplier fails to comply with stipulated period order may be cancelled and he will be declared defaulted and his any query will not be consider in future.
6. The undersigned Authority reserved the rights to accept or reject any or all quotation without giving any reason.
